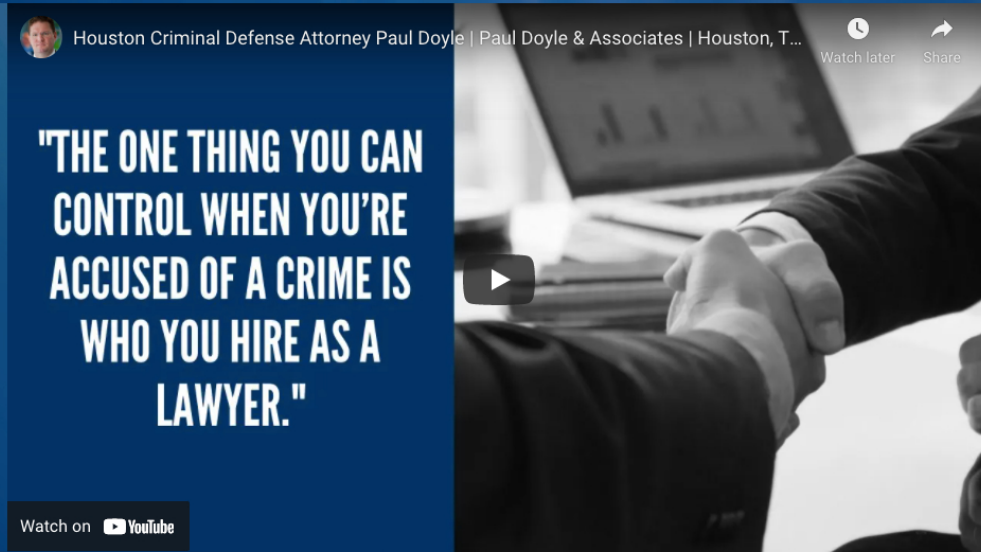

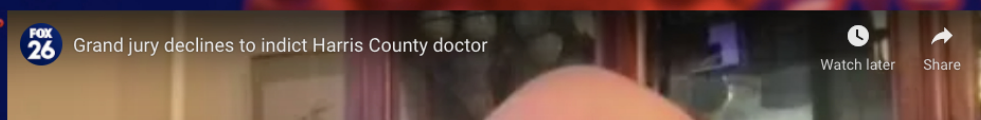

## DEFENDING A MEDICAL HERO

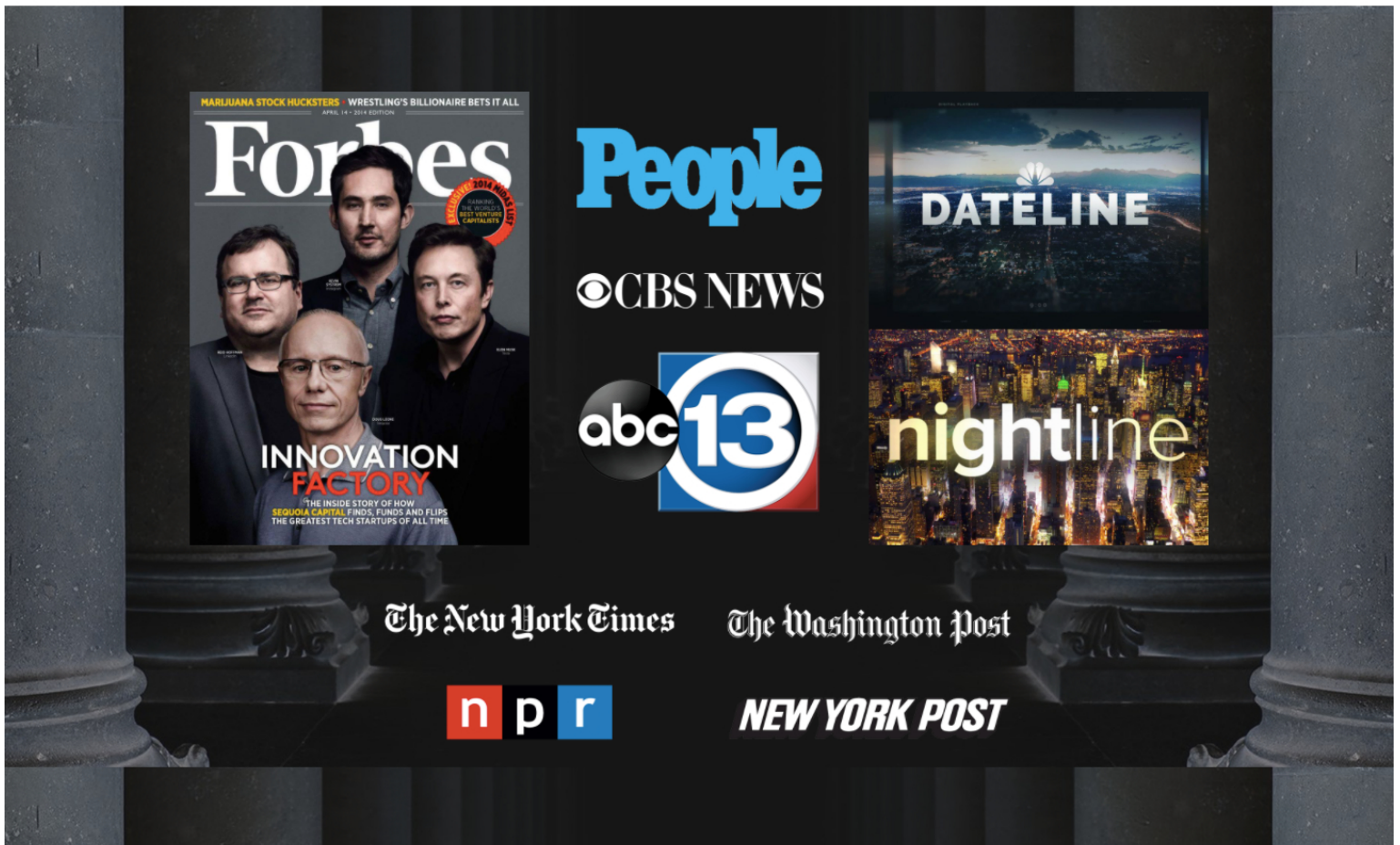

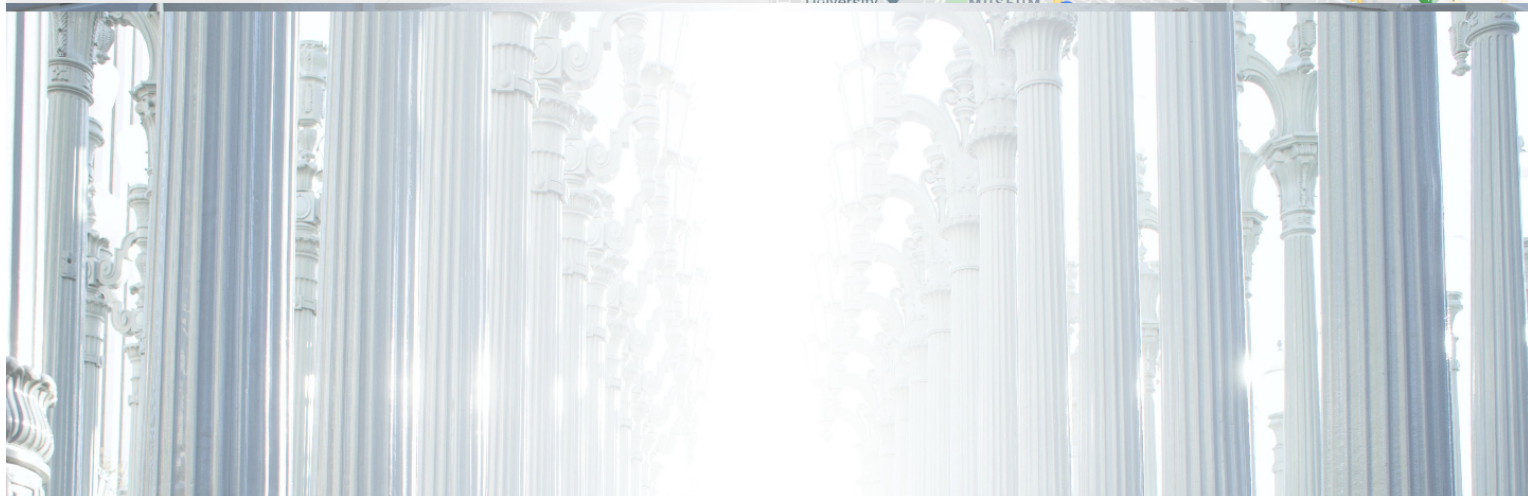
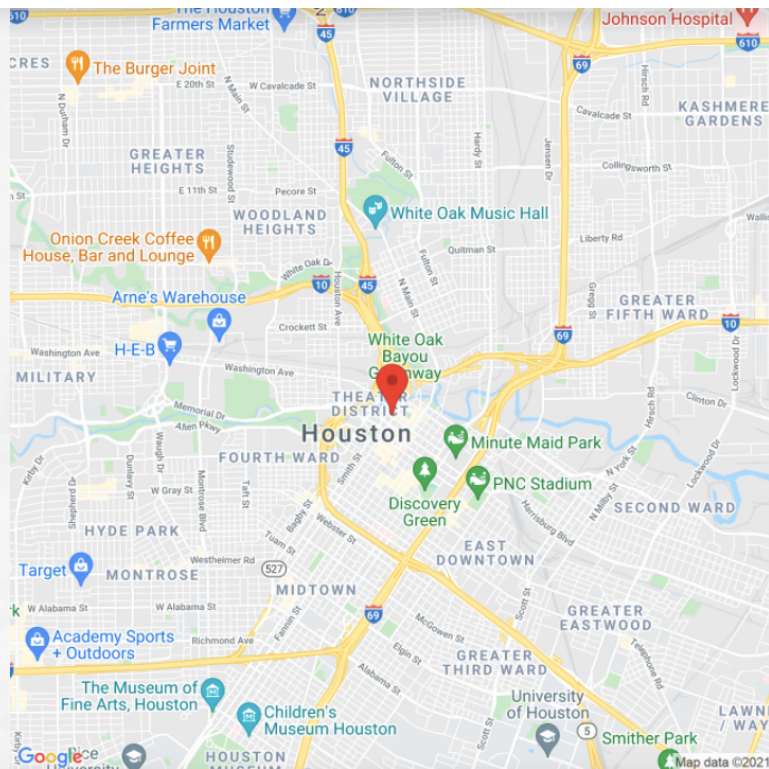
